### **Information about COVID Relief Funds**

During the six months ended October 31, 2025 and 2024, the Issuer recognized \$5.5 million and \$76.9 million, respectively, of COVID-19 related relief funds from the Federal Emergency Management Agency for expenses incurred during the pandemic. The COVID-19 funding recognized for the six months ended October 31, 2025 and 2024, are shown as part of non-operating revenue in the Statements of Revenue and Expenses and Changes in Net Position contained in this report.
